




#### Q2 If you think police officers should be required to wear body cameras, when should they be turned on?





#### Q3 Do you think filming interactions between police officers and civilians is an invasion of a civilian's privacy?





#### Q4 Do you think filming interactions between police officers is an invasion of a police officer's privacy?





#### Q5 Do you think police officers wearing body cameras will help prevent the use of excessive force by the police?





#### Q6 Do you think police officers wearing body cameras will help reduce accusations of excessive force against the police?





# Q7 Do you think civilians should have the right to know if a police officer is recording the interaction?





#### Q8 If a police officer was wearing a body camera, would that make you act differently when interacting with him or her?











#### **Q13 Household Income**




